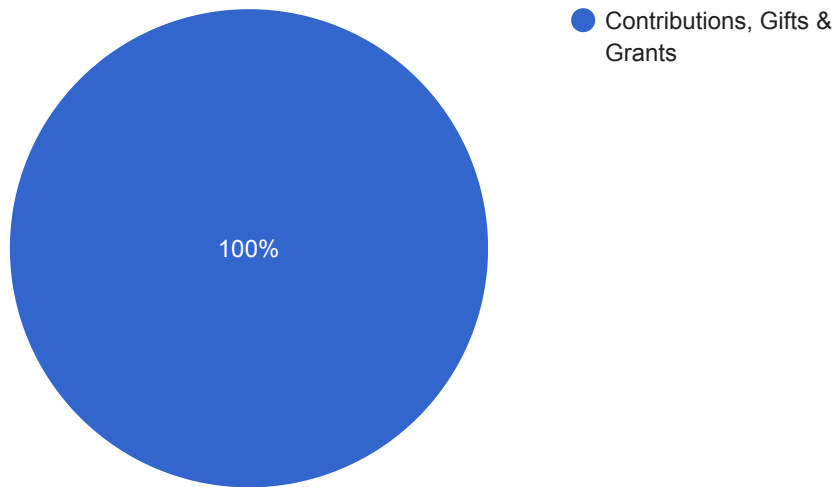

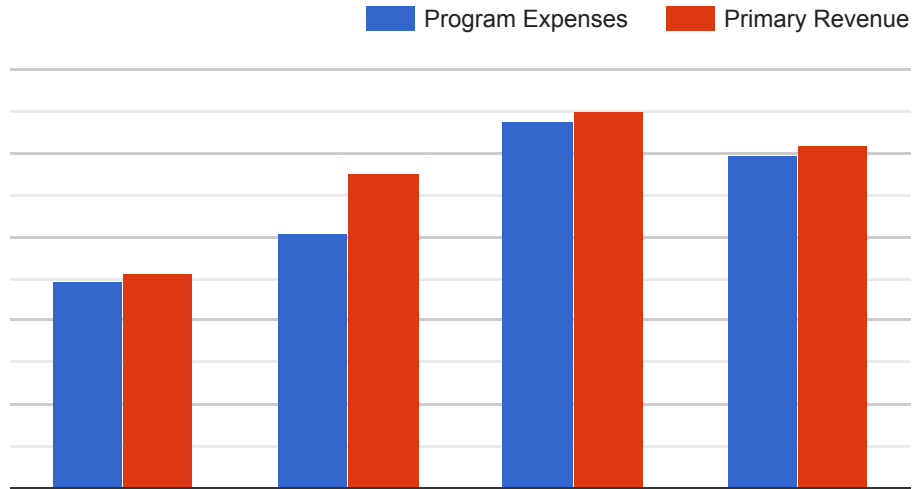
**Contributions Breakdown (FYE 12/2016)**
