ENTRY/ADMISSION CRITERIA

Girls and young people from 6 to 17 with 11 months who are in the custody of the Department of the Family and/or are in situations of social risk.

PARTICIPANT-CENTERED PHILOSOPHY

HTT services are designed around the identified needs and preferences of the girl, family, and custodian. The organization is committed to a system that promotes personal growth and dignity.

DESCRIPTION OF THE POPULATION SERVED

During the year 2020, HTT served a total of 22 girls. Of these, (86%) 19 were in the custody of the Family Department. Three (3) (14%) girls served were at social risk. The participants' ages ranged from 6 to 17 years to 11 months. 100% of the participants were Hispanic and single. Ten (10) participants received mental health services to address symptoms related to depressive disorders, anxiety disorders, trauma and stress disorder, destructive, impulse control, behavioral and neurodevelopmental disorders

In 2020, (4) discharges were reported, which are broken down as follows: (75%) were placed again with their custodians and/or guardians (family reunification). One (1) of the discharges was carried out, because the girl needed a higher level of care and supervision. Eight (8) of the participants were part of the Special Education program. In academic terms, all residents who completed their home-school year passed their respective grades. The participants' academic average (%) was (87%) or higher
